Halo Rule

- Lower 1 progressive

Brant from Say Something motioned to amend the rule to state 2 progressive for all divisions, Johnny from Freedom 2^{nd} the motion.

Discussion & Vote – In favor – 6, Opposed – 8, Abstained – 10 **DID NOT PASS**

Carl from R2R motioned to play to the upper division, Opie from Field Fiends 2nd the motion **Discussion & Vote** – In Favor – 21, Opposed – 5, Abstained – 3 **Motion Passed**

Tie Breaker

Current – 70 minute drop dead – score reverts back to last completed inning Robert from Misfits motioned to leave as is except for tournament games in which case the International Tie Breaker rule would be used. Johnny from Freedom 2nd the motion.

Discussion & Vote – In Favor – 0, Opposed – 9, Abstained – 20 DID NOT PASS

Carl from R2R – Point of clarity – tournament games cannot end in a tie. Motion to use Intl tiebreaker in the event that after the 7th inning time allows for continued play.

Discussion & Vote – In favor – 22, Opposed – 0, Abstained – 2 **Motion Passed**
